## **REGISTRATION AND VOTING**

Persons 18 years old, or those who will become 18 by the 2023 regular November election and who will possess the 30-day residential qualifications in precinct by said election, may register and vote (Const. §145; 116.025); however, no person can vote in any election until he/she reaches the age of 18 except in the primary election, and only when he/ she possesses the residential qualifications and will be 18 on or before the regular election day. (116.055) Each voter is required to sign name on precinct list at polls prior to voting. (117.225) Any voter unknown to election officers will be required to confirm his/her identification by a document such as an operator's license, social security card or credit card. (117.227)
